

ORDINANCE NO. 262-2026
AN ORDINANCE AMENDING SECTION 111.04 OF THE CODE OF ORDINANCES OF THE
CITY OF FREDERICKSBURG, IOWA, BY AMENDING PROVISIONS PERTAINING TO
ELECTRIC SERVICE RATES

BE IT ENACTED by the City Council of the City of Fredericksburg, Iowa:

SECTION 1. SECTION MODIFIED.

Section 111.04 of the Code of Ordinances of the City of Fredericksburg, Iowa, is hereby repealed and the following adopted in lieu thereof:

111.04 – RATES FOR SERVICE. Electric rates shall be furnished at the following monthly rates within the City (Code of Iowa Sec. 384.84):

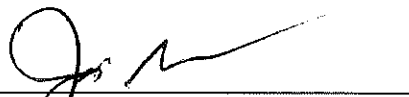
1. **Residential Rate** – Customer Charge: \$10.04; First 500 kWh: \$0.15841; Over 500 kWh: \$0.11537; Minimum Bill: \$10.04.
2. **Commercial Rate** – Customer Charge: \$15.05; First 1,000 kWh: \$0.18269; Over 1,000 kWh: \$0.11537; Minimum Bill: \$15.05.
3. **Large Commercial Rate** – Customer Charge: \$25.09; First 5,000 kWh: \$0.15003; Over 5,000 kWh: \$0.11407; Minimum Bill: \$25.09.
4. **Electric Heat (Non-Summer)** – Customer Charge: \$10.04; First 500 kWh: \$0.15841; Next 500 kWh: \$0.11537; Over 1,000 kWh: \$0.09280; Minimum Bill: \$10.04.
5. **Electric Heat (Summer)** – Customer Charge: \$10.04; First 500 kWh: \$0.15841; Next 500 kWh: \$0.11537; Minimum Bill: \$10.04.
6. **Industrial Demand Rate** – Customer Charge: \$125.46; Demand Charge: \$27.27/kW; Energy Charge: \$0.08871/kWh; Minimum Bill: \$125.46.
7. **City Electric Heat** – Non-Summer: First 500 kWh \$0.14719; Next 500 kWh \$0.10820; Over 1,000 kWh \$0.08347. Summer: First 500 kWh \$0.14719; Next 500 kWh \$0.10820.
8. **City Rate** – First 500 kWh: \$0.14719; Next 500 kWh: \$0.10820.
9. **City Treatment Plant Rate** – Demand Charge: \$27.27/kW; Energy Charge: \$0.07360/kWh.

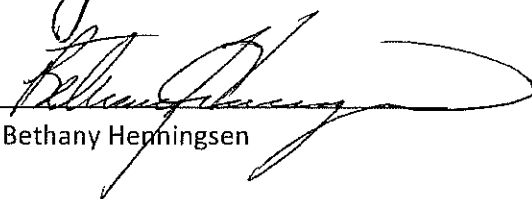
SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict are repealed.

SECTION 3. SEVERABILITY. If any part is invalid, the remainder shall not be affected.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect after passage, approval, and publication as provided by law.
